Dear members,

COVID-19 Advice Update June 2020

As we have had a number of recent announcements in regards to increases in COVID-19 cases, we have provided an update for those who are located in the identified hot spots in around Melbourne. The updated advice can be found on the RVAHJ website under the Blogs menu - Update 4 - Covid 19 Advice - June 2020. The key points from the advice update to reduce the risk of infection is as follows:

1. Document Witnessing & Certification Services

- All JPs over 70+ Years of age should refrain from all signing and certification
- duties
- Any JP with existing medical issues should refrain from all signing and certification duties
- All Document Signing Stations should if closed, remain so, or reconsider

plans to reopen services until the risk is reduced

- No Witnessing & Certification Services should be conducted at a JPs home
- Urgent Witnessing & Certification Services may be considered on a "one off"

basis provided all requirements and recommendations for social distancing

and other precautions are in place

 Refer all simple requests (Stat Decs & Certified Copies) to the list of Authorised Witnesses –

<u>justice.vic.gov.au/information-for-authorised-statutory-declaration-</u> witnesses

(NOTE: There are thousands of people in Victoria authorised to witness Stat Decs and Certify True copies)

 If you do decide to witness a document, always wash your hands and sanitise

any items used (pens etc) immediately follow each signing event (that is, between clients if there are multiples as well as at the end of the session)

and maintain the social distancing and other precautions at all times.

RVAHJ Training Academy – Now Live

The association has been working over the shut-down period to develop an online

training system for all authorised witnesses to be able to access and refresh or upgrade their knowledge on the key areas of service. The Training Academy portal

at https://training.rvahj.org.au is now ready after completing the testing phase with

our training team. The courses are free for members using a coupon code that is available from our Elwood office (Cathy). The online training academy portal has been established to provide all Authorised Witnesses the opportunity to learn at their

own pace the key areas required to provide service to the local community as an authorised witness, through an online learning management system (LMS) platform.

At the moment, the training modules that are available are as follows:

- Certified True Copies
- Statutory Declarations
- Assessing Capacity
- Voluntary Assisted Dying
- AHPRA Document Witnessing.
